Sub: Upgradation of the school from Middle to Secondary stage with effect from academic session 1993-94 (without aid).

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing-middle school to secondary level-without aid w.e.f. 1993-94 session to the fulfilment of the following terms & conditions:

1. That the school shall abide by the provisions of DSEA & R, 73 framed there under as well as the instructions issued from time to time.
2. That the School shall admit students without any discrimination of caste & creed.
3. That the School shall meet the additional liability of Secondary classes.
4. That a proper library shall be established and facilities for reading-room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students.
6. That the School shall strictly abide by the provisions of section 10(i) of the DSEA & R, 1973.
7. That the School shall not run any unrecognised classes or any other activities within the School premises and all the recognised classes shall be run at one place.
8. That the School shall dispense with the services, of unqualified and over-aged staff, if any, immediately.
9. That the school shall submit the returns to the Act Branch of the Dt. of Education as per rule 180 (1) of DSER 1973.
10. Fresh Health Certificate from MCD be obtained and produced to E.O. for verification.
11. The Management Committee shall regulate the functioning of school strictly, in accordance with the provisions of DSEA & R, 1973.
12. The Managing Committee of the School shall not increase fee in future academic session without prior approval of the Director of Education, which is a mandatory requirement under sub.section (3) of section 17 DSEA 1973.

13. That all the facilities prescribed under rule 50 & 51 of the DSER 1973 shall be made available to the students.
14. Proof to the effect that qualified staff has been appointed as per R. Rs. be provided for the verification of E.O.
15. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers & sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
16. That the school shall comply with the norms of the CBSE for affiliation for examination purposes.
17. Medical facilities/leave, LTC, bonus, Teaching Allowances, CPF etc. be paid since recognition of the School.
18. Provident Fund Register be maintained and Cash-book be completed and shown to E.O. of the zone concerned for certification from time to time.
19. That the management of the School shall create a Reserve Fund of Rs. 50,000/- (Fifty Thousand only).
20. That the violation of any instructions/conditions/rules & regulation of the department shall lead to the withdrawal of recognition of the school.
21. That report about the fulfilment of the above conditions shall be sent to the E.O. every six month.
22. That the School shall equip the science labs as per the norms of the Department and suitable facilities for practical work shall be provided to the students.





Sir,

With reference to your application on the subject cited above, I am directed to convey the permission of the Director of Education, Delhi to your society to establish a new school from class Ist to VIII(without aid) in Begumpur Area, Zone III of Distt. North subject to the following conditions:-

1. That the provision of DSEA/R,1973 and the rules framed thereunder shall be observed by the society.
2. That the management of the school will fulfil all the conditions laid down under rule 50 and will provide all the facilities given in Rule 51 of DSER,1973 to the institution.
3. That the management of the school will get the scheme of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed at prescribed Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheque.
5. That the management of the school will not ask for grant-in-aid from the department.
6. That in case that any time the mangement of the school is unable to run the school moveable/non-moveable property of the school will be transferred in the name of Director of Education, Delhi.
7. That the school will not run for the profit of any individual association or group of persons.
8. That the management of the school will apply for grant of recognition of the school under DSEA/R,1973 separately and recognition will not be granted unless statutory provisions of section 4(i)(a) to (f) read with rules 50 & 51 are fulfilled.
9. That all the recognised classes shall be run at one place only.
10. That the school shall be run under the control of Punarvas Kalyan Samiti (Regd.), Delhi and suitable funds will be made available for the constructions of suitable building on the land with the society, as declared as per the specifications of the department within a period of three yrs.
11. That adequate and sufficient accommodation of 12 sq.ft. per student shall be provided for class-room. The normal size of the class-room will be 24' X 20'. No other activities other than education shall be run.
